

PROCEEDINGS OF THE DISTRICT LEVEL COMMITTEE MEETING HELD ON 17.09.2009 AT - 11.30 A.M. IN THE OFFICE CHAMBER OF THE CDMO: PURI ON SELECTION OF CANDIDATE BY WAY OF DRAWING A LOT FOR OPENING OF DAY AND NIGHT MEDICINE SHOP IN THE CAMPUS OF KANAS C.H.C.(RESERVED FOR WOMEN CANDIDATE) OF PURI DISTRICT.

At the outset, the Chief Dist.Medical Officer,Puri welcomed the Representative of the Collector,Puri-A.D.M.(Gen.) as Chairman of the Dist.Level Selection Committee as well as all Members and participants present for the purpose.

First of all, the Chairman and Members of the Committee were apprised about the procedure adopted for selection of candidate on opening of Day and Night Medicine Shop by drawing a lot from among the applicants in a particular medical institution campus as per Govt.Guideline as under:-

It has been clarified by the Govt. in subsequent Guideline bearing No.22424-H., Dated 15.09.2005 in Point No.2(i) that " Regarding the weightage to be given in the selection of applicants when more than one eligible applicant is there with the same age group between 32-45 years, the selection will be finalised by the Committee at the Dist.Level consisting of Collector or ADM in absence of Collector as Chairman, C.D.M.O., A.D.M.O.(Medical) and any other district level officer to be nominated by the Collector as members by drawing a lot from among the applicants for opening of Day and Night Medical Store in a particular hospital campus in presence of the eligible applicants."

In accordance with the provision stated above in the clarification Govt.Guideline and decision taken by the Dist. Level Selection Committee meeting held on 18.08.2009 at 11-30 A.M. in the office chamber of the C.D.M.O.,Puri, the name of the following two eligible candidates for opening of Day and Night Medicine shop at Kanas-CHC campus were taken in to the panel list for selection.

Accordingly, suitable date and time was fixed for the purpose on 07.09.2009 at 11-30 A.M. for which the eligible candidates were informed to attend the said meeting on the scheduled date and time in the office chamber of the C.D.M.O., Puri positively, otherwise the C.D.M.O., Puri will not be held responsible for any inconvenience in future vide this office Regd. Post. With A.D. Letter No. 7798 dt. 29.08.09 and No. 7802 dated 29.08.09 respectively.

Consequent upon receipt of communication from this office, both the eligible candidates appeared before the C.D.M.O., Puri on the scheduled date and time, but unfortunately the meeting could not be held on 07.09.2009 At- 11-30 A.M. due to urgent un-avoidable engagement of the Chairman, Dist. Selection Committee, Puri. As a result of which the date of meeting was shifted from 07.09.2009 to another date.

In this connection, one notice in the signature of C.D.M.O., Puri was affixed in the office notice board vide No. 8028 dt. 07.09.2009 for the awareness of the eligible candidates and the signature of these two women candidates were also taken as they have seen the notice.

In the meantime, the Chairman of the Committee was requested to give his consent regarding future date and time for holding up the said meeting, where the same was fixed on 17.09.2009 at 11-30 A.M.

Accordingly the said eligible candidates were again informed to attend the meeting scheduled to be held on 17.09.2009 At- 11-30 A.M. by Regd. Post with A.D. vide this office letter No. 8231 dt. 09.09.2009 and No. 8234 dt. 09.09.2009 respectively.

Consequent upon receipt of communication from this end the eligible applicants appeared before the C.D.M.O., Puri for the purpose for which they were called for. Then their dated signature were obtained as a token of their presence. Apart from the above, Candidates also signed against the names of each other like Sabita Sahoo signed against the name of Manorama Kodmasingh and Manorama Kodmasingh against the name of Sabita Sahoo.

Afterwards, the both paper containing the name and address of eligible candidates were folded by the Chairman in presence of the Committee Members and eligible applicants and also kept in a transparent plastic jar with cover.

Besides the above, the Committee authorized to C.D.M.O., Puri to issue permission order to the selected candidate.
