The tender papers will be received up to 3.00 PM on dt 03.08.09 through registered post/speed post only in the above address and will be opened on dt. 04.08.09 at 11.00 AM in presence of the contractor or their authorized agents in the office of the D.R.C.S., P.D., Puri Cum-Chairman, R.M.C., Nimapara No tender will be received by hand or by courier service. The authority is not responsible for any loss or postal delay for receipt or delivery of tender documents. The tender should accompany with attested Xerox copies of valid registered license, VAT clearance certificate in from VAT-612 & PAN Card, Labour license, E.M.D. & Past Experience certificate for execution of Similar nature of work equivalent to the Tender Amount. The earnest money is to be deposited duly pledged in favour of the Secretary, RMC, Nimapara in shape of NSC / KVP or in shape of bank draft / Banker's Cheque drawn/ pledged in favour of the Secretary, RMS, Nimapara payable at SBI, Nimapara along with the tender document. The tender papers shall be submitted in a sealed cover for each work separately mentioning "TENDER PAPER FOR RMC WORK" only on the top of the cover without mentioning the name of the work, name of the tenderer.

**Special Clause: The tenderer quoting less than the Tender Value, should deposit the differential amount (i.e. difference between Tender Value at Column No.(3) & their quoted amount) along with the Tender Paper in shape of Bank Draft / Banker's Cheque drawn in favour of the Secretary, RMC, Nimapara payable at SBI, Nimapara failing which their tenders are liable for rejection.**

The tenders shall have to produce an undertaking in support of authenticity of documents / credentials including the EMD along with his Bid. The authority reserves the right to verify the authenticity of the documents at any time in case of doubts or complain arises there of.
