The quotations should reach to the undersigned on or before **18.11.2011** at **1 P.M** and the same will be opened on dated **18.11.2011** At **3 PM** in the office chamber of the C.D.M.O., Puri in presence of the quotationers or their authorised representatives. The authority reserves full rights to accept or reject any or all quotations without assigning any reason thereof.

**Receipt of Quotations**

The Sealed Quotation must be sent through Registered Post/Speed Post/Courier Service Only.

**Tender Cost**

The Quotationer is required to submit the tender cost amounting to Rs.500.00 (Non Refundable) in shape of Bank Draft from any nationalized Bank in favour of CDMO,Puri.

**Terms & Conditions**

1. The quotations should be properly sealed with insignia and be superscribed as **“QUOTATION FOR SUPPLY OF DRUGS & MEDICAL CONSUMABLES FOR BIJU GRAMINA SWASTHYA SIBIRA OF PURI DISTRICT”**.
2. Quotation should comprise of two bid system i.e Technical Bid and Financial Bid. Financial bid will be opened only those who qualify in their technical bid.
3. Attested copies of valid VAT/ INCOME TAX CLEARANCE Certificate/Valid Drug Licence from the competent authority are to be attached in the tender proposal.
4. The Rate & the name of the Manufacturer must be quoted in the tender proposal.
5. An undertaking of the quotationers indicating that the rate quoted for each item in the quotation does not exceed the prevailing market rate.
6. The supply should be executed within 7 (seven) days from the date of order.

7. Preference will be given to the DEPM / DGS & D rate holder firm.
8. Attested copy of Distributer license of Manufacturer must be attached.
9. Each item should contain long Expiry and proper labelling of D.O.M/D.O.E at the time of supply.
10. The manufacturer/supplier should have 3 years market standing in supply of drugs & medical consumables to Govt. hospitals/Corporate / PSU Hospitals in Odisha, copy must be submitted.
11. The Rate should be quoted in the prescribed format.
12. No alternative proposal of drugs & medical consumables will be accepted.
13. Non submission of any of the required document is liable for rejection of tender.
14. In case of any tender amendment and clarification, responsibility thereon lies with the tenderer to collect the same from the Web site before the last date of submission of tender & purchaser shall have no responsibility for any delay/omission on part of the tender.
